The Company's Monitoring Committee at its 16<sup>th</sup> Meeting on 1<sup>st</sup> April 2025 *inter alia* noted the due dates for payment of second and third tranche by BTL EPC Limited, the Successful Resolution Applicant (SRA), as envisaged in the National Company Law Tribunal Order dated 3<sup>rd</sup> December 2024 (NCLT Order).

The SRA representative apprised the Committee that BTL EPC Limited is willing to implement the Resolution Plan despite operational challenges faced by the Company, safeguard the existing bank guarantees, protect lenders' interests and accordingly, sought extension of time till 30<sup>th</sup> June 2025 for making the aforesaid payments, including interest for delayed payments, in terms of the NCLT Order.
