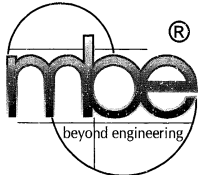

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, kindly be informed that the following has been taken on record at the Internal Meeting of the Chairman of the Monitoring Committee and the Independent Director held today:

- 1) Email correspondence dated 28th June 2024 received from the respective Stock Exchange, communicated to the Company, contending that McNally Bharat Engineering Company Limited was non-compliant with provisions of Reg. 3(5) and/or Reg. 3(6) of SEBI (Prohibition of Insider Trading) Regulations, 2015 for the financial year ended 31st March 2024, and directed the Company to place the fact of non-compliance to its Board of Directors within 1(one) month from the date of email communication or in the ensuing Board meeting, whichever occurred earlier;
